## Award Descriptions

#### I. Largest Broker-Assisted Lease Transaction of the Year Award

- Must be evidenced by a copy of the executed Lease and verbal acknowledgement of the principals if broker is not named in the Lease as Broker of Record.
- Must have been a registered WNYSCAR Member throughout calendar year 2018.
- Largest Lease Transaction will be determined based upon either largest gross dollar value and/or largest size building area.

#### II. Largest Sale Transaction of the Year Award

- Must be evidenced by a copy of the purchase agreement and verbal acknowledgement of the principal if broker is not named in the purchase agreement as Broker of Record.
- Must have been a registered WNYSCAR Member throughout calendar year 2018.
- Largest Sale Transaction will be determined based upon either the largest gross dollar value or the largest size building.

#### III. Transaction Volume of the Year Award

- Must have been a registered WNYSCAR Member throughout calendar year 2018.
- Must be evidenced by the total number of lease or sales transactions (not \$ volume) and verified by broker/agent being named in sales/lease document; or Landlord/Seller/Buyer acknowledgement in writing; or a verification by his/her General Manager or Broker of Record.
